The Grand Jury charges:

COUNT ONE

[18 U.S.C. §§ 2252A(a)(2)(A), (b)(1)]

On or about May 15, 2016, in Los Angeles County, within the Central District of California, and elsewhere, defendant FERNANDO VAZQUEZ GARCIA, also known as ("aka") "Fernie," aka "anon_68209eae@ares" ("GARCIA"), knowingly received, onto an eMachines laptop, bearing serial number LXN6402008943400A01601 (the "eMachines Laptop"), child pornography, as defined in Title 18, United States Code, Section 2256(8)(A), that had been mailed, and, using any means and facility of interstate and foreign commerce, had

1 been shipped and transported in and affecting interstate and foreign
2 commerce by any means, including by computer, knowing that the images
3 were child pornography.

4 The child pornography that defendant GARCIA received on the
5 eMachines Laptop consisted of a video titled "10 years old forced
6 sex(3).mpg."

COUNT TWO

[18 U.S.C. §§ 2252A(a)(5)(B), (b)(2)]

On or about February 9, 2017, in Los Angeles County, within the Central District of California, and elsewhere, defendant FERNANDO VAZQUEZ GARCIA, also known as ("aka") "Fernie," aka "anon_68209eae@ares" ("GARCIA"), knowingly possessed a Hitachi Hard Drive, bearing serial number QCCPSDJG (the "Hitachi Hard Drive"), which contained at least one image of child pornography, as defined in Title 18, United States Code, Section 2256(8)(A), which images involved a prepubescent minor and a minor who had not attained 12 years of age, that had been mailed, and shipped and transported using any means and facility of interstate and foreign commerce and in and affecting interstate and foreign commerce by any means, including by computer, knowing that the images were child pornography.
